SECURITIES, STOCK AND BONDS: The School Sisters of Notre Dame Central Pacific Province, Inc., welcomes gifts of publicly traded securities, stocks or bonds.

IRA DISTRIBUTIONS: At an age determined by the IRS, donors can contribute up to \$100,000 from their IRA directly to the

School Sisters of Notre Dame Central Pacific Province, Inc., to avoid paying income taxes on the distribution. This is known as a qualified charitable distribution.

DONOR-ADVISED FUNDS: A donor-advised fund, or DAF, is a giving account established at a public charity. It allows donors to make a charitable contribution, receive an immediate tax deduction and then recommend grants from the fund over time. You can recommend the School Sisters of Notre Dame Central Pacific Province, Inc., receive a grant from your DAF.

GIFTS OF PROPERTY: A charitable contribution of property – a primary residence, vacation home, commercial real estate or parcel of land – is a gift that might have income and tax advantages.
